Notice to Non Member

As the duly designated collective bargaining representative for conductors and trainmen under the Railway Labor Act, the UTU must represent every employee working or holding seniority in train service on the property with respect to bargaining, contract administration, arbitration, and claim and grievance handling, including non-members. To provide support for the substantial financial and administrative burden incurred by the UTU in representing and protecting the rights of employees working in train service who are not UTU members, the UTU has entered into an agreement that would amend certain existing agreements governing train service seniority to ensure that the organization will be the exclusive representative for on property claim, grievance and discipline handling and will receive financial support from all employees whose seniority rights and interests we are required by law to protect.

Accordingly, pursuant to the Agreement dated November 1 2004, the UTU and its duly designated officers shall have the exclusive right to represent employees working in train service in carrier-level grievance, claim and disciplinary proceedings. Only the UTU may represent employees working under the jurisdiction of a UTU collective bargaining agreement on the property

Further, each employee working in train service under a collective bargaining agreement represented by the UTU that does not hold UTU membership will be required to pay a monthly Seniority Maintenance Fee (SM) to the UTU in order to continue to accumulate train service seniority.

You have been identified as working in train service as of ______ and records indicate you are not a member of the United Transportation Union. Pursuant to the Agreement dated November 1. 2004 you are required to pay to the UTU a seniority maintenance fee, or you may become a UTU member. The seniority maintenance fee necessary to comply with the Agreement is \$78.39 per month, if you choose to pay the seniority maintenance fee to comply with the Agreement you will be a non-member and will have no rights of membership, such as voting on agreements, participating in elections, or attending local meetings. Should you decide to become a UTU member, you would become a member of Local 113 and pay fill dues of \$84.30 per month.

UTU dues or the Seniority Maintenance Fee are payable prior to the first day of the month in which they are due. Please advise the treasurer of Local 113 listed below as to whether you choose to pay the seniority maintenance fee due from non-members or pay fill dues and become a UTU member. You must also advise Treasurer Robert Olague if you will be paying by check or would like to be placed on payroll deduction. The first dues or SM fee will be payable on June 1, 2005.

A non-member of UTU assigned to train service who fails to join the UTU or pay the SM fee when due, will have their individual train service seniority frozen When seniority is frozen, all employees on the trainmen's seniority roster below the employee that elected to not pay the Seniority Maintenance Fee, upon accumulating years of service greater than that of the non member at the time his seniority was frozen, will be permanently placed ahead of them on the seniority roster.
